

CRIMINAL JUSTICE AND POLICE ACT 2001

Alcohol Consumption in Designated Public Places Order 2005

St Albans City & District Council (in this Order called “the Council”) hereby makes the following order under Section 13(2) of the said Act:

The land described in the Schedule below, being land in the area of the Council which is land to which the Criminal Justice and Police Act 2001 applies, is hereby designated for the purposes of that Act.

This Order may be cited as the Alcohol Consumption in Designated Public Places for the area of Harpenden Order 2005 and shall come into force on Sunday 1st January 2006.
